

UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT
("Undertaking")

of

Ms. Sabrina Joyce Diaram

to

COLLEGE OF PHYSICIANS AND SURGEONS OF ONTARIO
(the "College")

A. PREAMBLE

- (1) I, **Sabrina Joyce Diaram**, acknowledge that the College initiated an investigation into whether I am operating in contravention of the *Regulated Health Professions Act, 1991*, S.O. 1991, c. 18, as amended (*RHPA*) and/or the *Medicine Act, 1991*, S.O. 1991, c. 30 (*Medicine Act*).
- (2) I, **Sabrina Joyce Diaram**, acknowledge that I am not a member of the College or of any other regulated health profession under the *RHPA*.
- (3) I, **Sabrina Joyce Diaram**, acknowledge that I have used or allowed the term "doctor", "MD", and a variation and/or an abbreviation thereof to be used in describing me on various websites and business cards in the course of providing or offering to provide health care to individuals. The College has provided me with a copy of the relevant provisions of the *Medicine Act* and the *RHPA*. The College has advised me that I am operating in contravention of the statutes noted above in paragraph (1), and further advised me that violating certain provisions of these statutes constitutes an offence at law.

B. UNDERTAKING

- (4) I, **Sabrina Joyce Diaram**, undertake to abide by the provisions of this Undertaking, effective immediately.

(5) RESTRICTIONS

- (a) I, **Sabrina Joyce Diaram**, undertake that I will permanently refrain from using the titles "doctor", "Dr", "MD" and/or any variation or abbreviation thereof, in the course of providing health care services to any individual, and further undertake not to hold myself out as a doctor. In doing so, I will:
 - i. Remove any or all references to the titles "doctor", "Dr", "MD" and/or any variation or abbreviation thereof, from my

advertisements, signages, social media accounts, brochures, business cards and on any other websites.

- ii. Only perform controlled acts in compliance with section 27(1) of the *RHPA* and the College's *Policy Delegation of Controlled Acts*.

C. ACKNOWLEDGEMENT

- (6) I, **Sabrina Joyce Diaram**, acknowledge that I have read and understand the provisions of this Undertaking and that I have obtained independent legal counsel in reviewing and executing this Undertaking, or have waived my right to do so.
- (7) I, **Sabrina Joyce Diaram**, acknowledge that a breach by me of any provision of this Undertaking may result in the College taking legal action against me, including commencing an application in court for injunctive relief.
- (8) I, **Sabrina Joyce Diaram**, acknowledge that the College may provide this Undertaking and/or any other relevant information to any business where I work or am employed, and to any organization or academic institution to which I have claimed to be a member and/or a graduate.
- (9) I, **Sabrina Joyce Diaram**, acknowledge that this Undertaking may be posted on the College's website: <http://www.cpso.on.ca/> under Unregistered Practitioners as notification to the public that I am not a registered member of the College.
- (10) I, **Sabrina Joyce Diaram**, acknowledge that the College will continue to monitor my compliance with the provisions of this Undertaking.
