

# UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT ("Undertaking")

of

to

# COLLEGE OF PHYSICIANS AND SURGEONS OF ONTARIO (the "College")

#### A. PREAMBLE

- Nessrine Hussein, acknowledge that the College initiated an investigation into whether I am operating in contravention of the Regulated Health Professions Act, 1991, S.O. 1991, c. 18, as amended (RHPA) and/or the Medicine Act, 1991, S.O. 1991, c. 18 (Medicine Act).
- (2) I, Nessrine Hussein, acknowledge that I am not a member of the College or of any other regulated health profession under the RHPA.
- (3) I, Nessrine Hussein, acknowledge that I have performed Controlled Acts in contravention of the RHPA. The College has provided me with a copy of the relevant provisions of the Medicine Act and the RHPA. The College has advised me that I am operating in contravention of the statutes noted above in paragraph (1), and further advised me that violating certain provisions of these statutes constitute an offence at law.
