performing controlled acts in the course of providing health care services a). to any individual including but not limited to:

communicating to the individual or his or her representative a diagnosis identifying a disease or disorder as the cause of symptoms of the individual in circumstances in which it is reasonably foreseeable that the individual or his or her personal representative will rely on the diagnosis;

performing a procedure on tissue below the dermis, below the surface or the mucus membrane;

administering a substance by injection or inhalation; and

putting an instrument, hand or finger beyond the point in the nasal passages where they normally narrow, or beyond the labia majora; and

treating or advising a person with respect to his or her health in b) circumstances in which it is reasonably foreseeable that serious bodily harm may result from the treatment or advice or from an omission from them.

2. THIS COURT FURTHER ORDERS that costs of this day be reserved to the Application Judge.
